**JOHN HANCOCK FINANCIAL OPPORTUNITIES FUND
NOTICE TO SHAREHOLDERS – SOURCES OF DISTRIBUTION UNDER SECTION
19(a)**

BOSTON, MA (March 31, 2025) – John Hancock Financial Opportunities Fund (NYSE: BTO) (the “Fund”), a closed-end fund managed by John Hancock Investment Management LLC and subadvised by Manulife Investment Management (US) LLC, announced today sources of its quarterly distribution of \$0.6500 per share paid to all shareholders of record as of March 13, 2025, pursuant to the Fund’s managed distribution plan. This press release is issued as required by an exemptive order granted to the Fund by the U.S. Securities and Exchange Commission.

Notification of Sources of Distribution

This notice provides shareholders of the John Hancock Financial Opportunities Fund (NYSE: BTO) with important information concerning the distribution declared on March 3, 2025, and payable on March 31, 2025. No action is required on your part.

Distribution Amount Per Common Share: \$0.6500

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.

The Fund has declared the March 2025 distribution pursuant to the Fund's managed distribution plan (the "Plan"). Under the Plan, the Fund makes fixed quarterly distributions in the amount of \$0.6500 per share.
